

The results of a survey on how different types of savings by households are taxed in each of the OECD countries. The chapter for each country contains sections showing the basic tax provisions (including income, net wealth, capital gains, gift and inheritance, and financial transaction taxes), the treatment of alternative savings instruments (including private pensions, housing, bank deposits, bonds, equities, investment trusts, life insurance, other assets, and consumer credit), non-tax subsidies or premiums, a bibliography of recent studies on the topic, provisions relating to non-residents, and recent and future changes. As the background report to Taxation and Household Saving, this publication will be of particular interest to tax and public finance specialists, and will contribute to the continuing policy debate on whether and how governments should seek to influence private saving.
