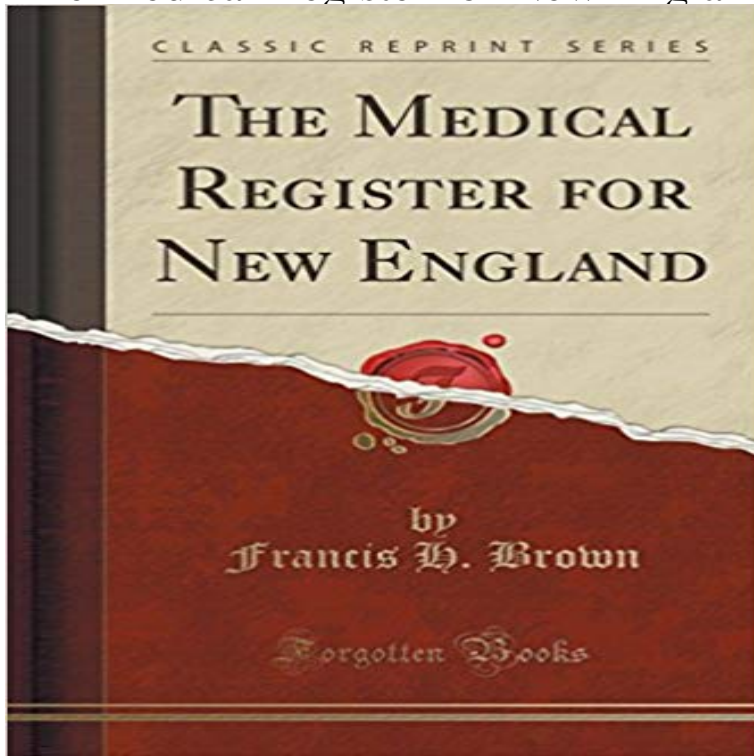

The names of many worthy men would have escaped notice, some questionable names might have been included, and the distinction between worthy and unworthy would, in many cases, have seemed invidious. The lists of the societies, except that of Vermont, are such as are authorized by the secretaries of such organizations; in that State the author is indebted to a friend for the most accurate catalogue which can be obtained.
