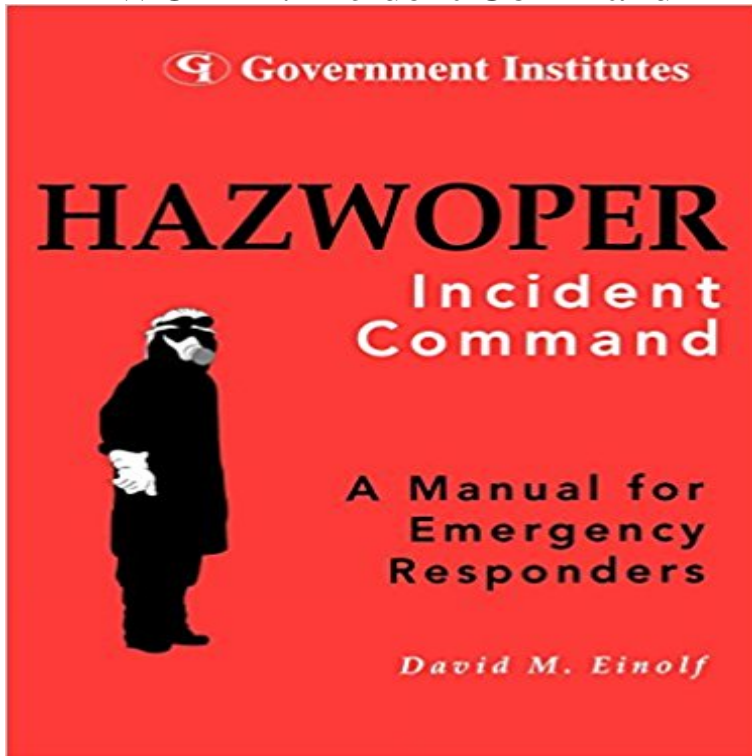


## HAZWOPER: Incident Command
