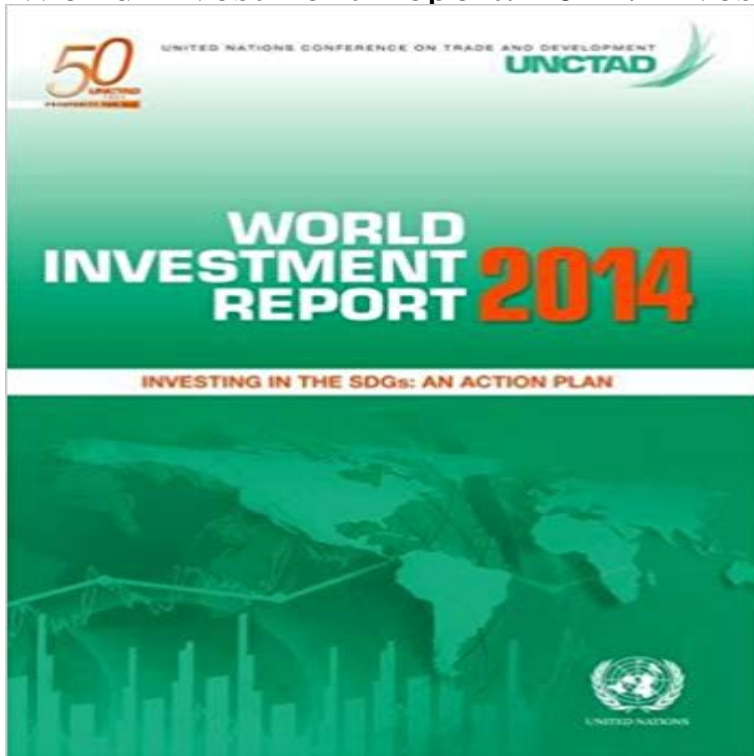


# World Investment Report: 2014: Investing in the Sdgs - An Action Plan
