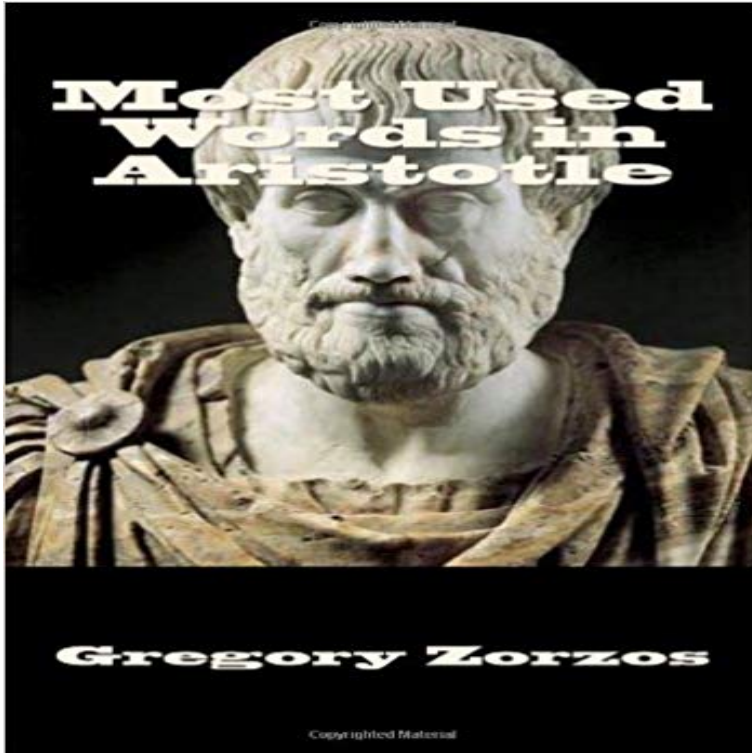


Most Used Words in Aristotle
